- b) All applicable fees must be paid directly to the National Council for Construction (NCC) through its Bank accounts as provided herein.
- c) All applicable fees paid to the NCC are Non-refundable and Non-transferable. Electronic Bank transfers will only be receipted after two days of the transfer and upon confirmation that the transfer has cleared.
- d) Attach a separate sheet where space on the form is limited for additional information.
- e) All applicants for renewal should attach copies of their current NCC and JV Registration Certificate(s).
- f) Late renewals shall attract penalty fees as follows: 25% of the Annual registration fee from 15th January to 31st January in the current year. 2% cumulative increment for each subsequent month (Please refer to table 5.0). Contractors who do not intend to renew their NCC Joint Venture certificate should notify the council in writing before 14th January of the registration year failure to which a 100% annual fee will be charged for each year of non-renewal as penalty, at the time of the next renewal. Note that the Council shall not waive penalties on any late renewal submissions.
- g) A joint venture renewal certificate will be issued to registered contractors whose NCC certifications are current and in good standing.
- h) Ensure that your application for **EXPRESS REGISTRATION** is scrutinized by NCC before any payments are made.
